## Canyon Dance Academy Studio Policies 2020-2021

### Dress Code Requirements

All Dancers must wear their hair secured off their neck.

**Creative 3s and 4s:** Pink ballet tights, pink ballet shoes (no satin slippers), any style pink or black leotard.

**Kinderdance:** pink ballet tights, pink ballet shoes (no satin slippers), black tap shoes, pink or black leotard.

**Ballet 1 & up:** pink ballet tights, pink ballet shoes (no satin slippers), black leotard, **hair in a bun**. Ballet skirts are permitted.

**Ballet 3 & up:** Pink split sole shoes are required

**Jazz 1, 2, 3 & 4:** any color/style leotard or fitted tank top, dance pants or spandex shorts, tan jazz shoes. No bare legs!

**Int Jazz, Int/Adv Jazz & Adv Jazz:** any color/style leotard or fitted tank top, dance pants or spandex shorts, & tan jazz shoes (it is recommended to have on hand black jazz shoes as well, or as needed for costumes). No bare legs!

**Tap classes:** any color/style leotard or fitted tank top, dance pants or shorts, black tap shoes. No bare legs!

**Hip Hop:** any color/style leotard or fitted tank top or t-shirt, dance pants (NO JEANS) or shorts, black dance sneakers with a black sole.

**No bare legs!**

### Tuition

Monthly tuition is due the 1<sup>st</sup> class of each month and can be placed in the tuition box located inside our lobby. If you choose to mail your payment please do so at least 10 days in advance to: Canyon Dance Academy, 2922 E. Cleveland Blvd, Suite 600, Caldwell, 83605. Returned check fee is \$25 due upon receipt. Tuition not received by the 15th will receive a \$7 late fee. Individual classes are \$10 each. *There are no refunds on tuition and dancers will not be allowed to perform in recitals on past due accounts. Months with breaks have been accounted for and therefor do not have a prorated tuition amount.*

### Attendance: Classes run September 8<sup>th</sup> through May 29<sup>\*\*</sup>

It is imperative that students come to class on time for warm-up to prevent injuries. *There are no tuition refunds for missed classes.*

Make-up classes can be arranged with your teacher. Please note that missing class both affects the students and the teacher. If your child falls behind, he or she may need to schedule private lessons to catch up. Private lessons costs are determined by the instructor.

If your enrolled class meets twice a week, you must commit to both days. Please give 30 days written notice if canceling enrollment.

**Please pick up your child promptly. While in Phase 3 or 4, the lobby will remain closed.**

### Holidays/Studio Closures

Unless specifically noted below, classes will always be in session. In the case of weather-related closures, an email will be sent.

There will be **no classes** on the following days:

**Thanksgiving- Wednesday, November 25- Saturday, November 28**

**Winter Break- Monday, December 21-Saturday, January 2.** Regular classes resume Monday, January 4.

**Spring Break- Monday, March 22 through Saturday, March 27.** Regular classes resume Monday, March 29.

COVID/Emergency Closures notifications will be emailed as quickly as possible.

### Performances: Accounts must be in good standing in order to perform

**Winter Show** is held in December, pending COVID restrictions. There is a \$10 costume fee per class enrolled. Once the costume is returned in good condition your account will receive \$5 credit per class enrolled.

**Spring recital** is usually the weekend after Memorial Weekend. Costumes are **\$40** each for **Creative 3s, 4s, Kinderdance, Ballet 1, 2 & 2, Jazz 1, 2 & 3, Tap 1 & 2, 3 & 4, Hip Hop 1 & 2** and **\$45** for **Ballet 4, 5, 6, Pre-pointe, Beg Pointe & Pointe, Jazz 4, 5, Int Jazz I, Int Jazz II, Int/Adv Jazz, Adv Jazz, Int Tap, Adv Tap, Hip Hop 3 & Adv Hip Hop**. Payment is due in December.

We do our best to give ample notice of that schedule well in advance. In the month of May, we will have pictures taken in your child's costume(s) at the studio. Those will be available for pick up at a later date.

*Reserved Seating Tickets for performances are available to purchase prior to the performances and will be announced in future updates.*

*The funds raised from tickets sales go toward the rental of the facility and other costs associated with the performance.*
