## Canyon Dance Academy Studio Policies 2022-2023

### **Dress Code Requirements**All Dancers must wear their hair secured off their neck.

**Creative 3s and 4s:** Pink ballet tights, pink ballet shoes (no satin slippers), any style pink or black leotard.

**Kinderdance:** pink ballet tights, pink ballet shoes (no satin slippers), black tap shoes, pink or black leotard.

**Ballet 1 & up:** pink ballet tights, pink ballet shoes (no satin slippers), black leotard, **hair in a bun**. Ballet skirts are permitted.

**Ballet 3 & up:** pink ballet tights, black leotard, pink split sole shoes, hair in a bun. Ballet skirts are permitted.

**Boys/Men in Ballet, levels 5 and up:** form fitting black pants, dance belt, white shirt & black split sole ballet shoes.

**Jazz 1, 2, 3 & 4:** any color/style leotard or fitted tank top, dance pants or spandex shorts, **tan jazz shoes**.

**Int Jazz, Int/Adv Jazz & Adv Jazz:** any color/style leotard or fitted tank top, dance pants or spandex shorts, & **tan jazz shoes** (it is recommended to have on hand black jazz shoes as well, or as needed for costumes).

**Tap classes:** any color/style leotard or fitted tank top, dance pants or shorts, black tap shoes.

**Hip Hop:** any color/style leotard or fitted tank top or t-shirt, dance pants, etc that cover the knees (NO JEANS), black dance sneakers.

### **Tuition**

**Monthly tuition is due the 1<sup>st</sup> class of each month and can be placed in the tuition box located inside our lobby.** If you choose to mail your payment please do so at least 10 days in advance to: Canyon Dance Academy, 2922 E. Cleveland Blvd, Suite 600, Caldwell, 83605. **Returned check fee is \$25 due upon receipt. Tuition not received by the 10th will receive a \$7 late fee.** Individual classes are \$10 each. ***There are no refunds on tuition and dancers will not be allowed to perform in recitals on past due accounts. Months with breaks have been accounted for and therefor do not have a prorated tuition amount.***

### **Attendance: Classes run September 6 through May 27\*\***

It is imperative that students come to class on time for warm-up to prevent injuries. *There are no tuition refunds for missed classes.* Make-up classes can be arranged with your teacher. Please note that missing class both affects the students and the teacher. If your child falls behind, he or she may need to schedule private lessons to catch up. Private lessons costs are determined by the instructor. If your enrolled class meets twice a week, you must commit to both days. Please give 30 days' notice if canceling enrollment.

**Please pick up your child promptly.**

### **Holidays/Studio Closures**

Unless specifically noted below, classes will always be in session. In the case of weather-related closures, an email will be sent.

There will be **no classes** on the following days:

**Halloween- Monday, October 31st**

**Thanksgiving- Tuesday, November 22- Saturday, November 26**

**Winter Break- Thursday, December 22-Wednesday, January 4.** Regular classes resume Thursday, January 5

**Spring Break- Monday, March 27 through Saturday, April 1.** Regular classes resume Monday, April 3.

COVID/Emergency Closures notifications will be emailed as quickly as possible.

\*\*Please ensure that we have your correct email address, as this is our main way of communicating with our parents and dancers.

### **Performances: Accounts must be in good standing in order to perform**

**Winter Show** is typically held in December, *pending COVID restrictions*. There is a \$10 costume fee per class enrolled. Once the costume is returned in good condition your account will receive \$5 credit per class enrolled.

**Spring recital** is usually the weekend after Memorial Weekend. Costumes are **\$40 each** for Creative 3s, Creative 4s & Kinderdance, **\$45 each** for Ballet 1, 2,3 & 4 Jazz 1, 2, 3 & 4, Tap 1 & 2, 3 & 4, Hip Hop 1 & 2 and **\$50 each** for Ballet 5, 6, Pre-pointe, Beg Pointe & Pointe, Jazz 5, Int Teen Jazz, Int/Adv Jazz & Adv Jazz, Adv Tap, Hip Hop 3 & Adv Hip Hop, Contemporary. Payment is due in December.

We do our best to give ample notice of that schedule well in advance. In the month of May, we will have pictures taken in your child's costume(s) at the studio. Those will be available for pick up at a later date.

*Reserved Seating Tickets for performances are available to purchase prior to the performances and will be announced in future updates. The funds raised from tickets sales go toward the rental of the facility and other costs associated with the performance.*
