## **WAIVER AND RELEASE OF LIABILITY**

IN CONSIDERATION OF the risk of injury that exists while participating in ALL Dance Forms (hereinafter the "Activity"); and

IN CONSIDERATION OF my desire to participate in said Activity and being given the right to participate in same;

I HEREBY, for myself, my heirs, executors, administrators, assigns, or personal representatives (hereinafter collectively, "Releasor," "I" or "me", which terms shall also include Releasor's parents or guardian if Releasor is under 18 years of age), knowingly and voluntarily enter into this WAIVER AND RELEASE OF LIABILITY and hereby waive any and all rights, claims or causes of action of any kind arising out of my participation in the Activity; and

I HEREBY release and forever discharge Canyon Dance Academy, located at 2922 East Cleveland Boulevard, Suite 600, Caldwell, ID 83605, their affiliates, managers, members, agents, attorneys, staff, volunteers, heirs, representatives, predecessors, successors and assigns (collectively "Releasees"), from any physical or psychological injury that I may suffer as a direct result of my participation in the aforementioned Activity.

I AM VOLUNTARILY PARTICIPATING IN THE AFOREMENTIONED ACTIVITY AND I AM PARTICIPATING IN THE ACTIVITY ENTIRELY AT MY OWN RISK. I AM AWARE OF THE RISKS ASSOCIATED WITH PARTICIPATING IN THIS ACTIVITY, WHICH MAY INCLUDE, BUT ARE NOT LIMITED TO: PHYSICAL OR PSYCHOLOGICAL INJURY, PAIN, SUFFERING, ILLNESS, DISFIGUREMENT, TEMPORARY OR PERMANENT DISABILITY (INCLUDING PARALYSIS), ECONOMIC OR EMOTIONAL LOSS, AND DEATH. I UNDERSTAND THAT THESE INJURIES OR OUTCOMES MAY ARISE FROM MY OWN OR OTHERS' NEGLIGENCE, CONDITIONS RELATED TO TRAVEL TO AND FROM THE ACTIVITY, OR FROM CONDITIONS AT THE ACTIVITY LOCATION(S). NONETHELESS, I ASSUME ALL RELATED RISKS, BOTH KNOWN AND UNKNOWN TO ME, OF MY PARTICIPATION IN THIS ACTIVITY.

I FURTHER AGREE to indemnify, defend and hold harmless the Releasees against any and all claims, suits or actions of any kind whatsoever for liability, damages, compensation or otherwise brought by me or anyone on my behalf, including attorney's fees and any related costs.

I FURTHER ACKNOWLEDGE that Releasees are not responsible for errors, omissions, acts or failures to act of any party or entity conducting a specific event or activity on behalf of Releasees. In the event that I should require medical care or treatment, I authorize Canyon County Dance Academy to provide all emergency medical care deemed necessary, including but not limited to, first aid, CPR, the use of AEDs, emergency medical transport, and sharing of medical information with medical personnel. I further agree to assume all costs involved and agree to be financially responsible for any costs incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance.

I FURTHER ACKNOWLEDGE that this Activity may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. I agree not to participate in the Activity unless I am medically able and properly trained, and I agree to abide by the decision of the Canyon Dance Academy official or agent, regarding my approval to participate in the Activity.

I HEREBY ACKNOWLEDGE THAT I HAVE CAREFULLY READ THIS "WAIVER AND RELEASE" AND FULLY UNDERSTAND THAT IT IS A RELEASE OF LIABILITY. I EXPRESSLY AGREE TO RELEASE AND DISCHARGE CANYON DANCE ACADEMY AND ALL OF ITS AFFILIATES, MANAGERS, MEMBERS, AGENTS, ATTORNEYS, STAFF, VOLUNTEERS, HEIRS, REPRESENTATIVES, PREDECESSORS, SUCCESSORS, AND ASSIGNS, FROM ANY AND ALL CLAIMS OR CAUSES OF ACTION AND I AGREE TO VOLUNTARILY GIVE UP OR WAIVE ANY RIGHT THAT I OTHERWISE HAVE TO BRING A LEGAL ACTION AGAINST CANYON DANCE ACADEMY FOR PERSONAL INJURY OR PROPERTY DAMAGE.

To the extent that statute or case law does not prohibit releases for ordinary negligence, this release is also for such negligence on the part of Canyon Dance Academy, its agents, and employees.

I agree that this Release shall be governed for all purposes by Canyon Dance Academy law, without regard to any conflict of law principles. This Release supersedes any and all previous oral or written promises or other agreements.

In the event that any damage to equipment or facilities occurs as a result of my or my family's or my agent's willful actions, neglect or recklessness, I acknowledge and agree to be held liable for any and all costs associated with any such actions of neglect or recklessness.

THIS WAIVER AND RELEASE OF LIABILITY SHALL REMAIN IN EFFECT FOR THE DURATION OF MY PARTICIPATION IN THE ACTIVITY, DURING THIS INITIAL AND ALL SUBSEQUENT EVENTS OF PARTICIPATION.

## **Canyon Dance Academy Studio Policies 2023-2024**

### **Dress Code Requirements: All Dancers must wear their hair secured off their neck.**

**Creative 3s and 4s:** Pink ballet tights, pink ballet shoes (no satin slippers), any style pink or black leotard.

**Kinderdance:** pink ballet tights, pink ballet shoes (no satin slippers), black tap shoes, pink or black leotard.

**Ballet 1 & up:** pink ballet tights, pink ballet shoes (no satin slippers), black leotard, **hair in a bun.** Ballet skirts are permitted.

**Ballet 3 & up:** pink ballet tights, black leotard, pink split sole shoes, hair in a bun. Ballet skirts are permitted.

**Boys/Men in Ballet, levels 5 and up:** form fitting black pants, dance belt, white shirt & black split sole ballet shoes.

**Jazz 1, 2, 3 & 4:** any color/style leotard or fitted tank top, dance pants or spandex shorts, tan jazz shoes.

**Int Jazz, Int/Adv Jazz & Adv Jazz:** any color/style leotard or fitted tank top, dance pants or spandex shorts, & tan jazz shoes (it is recommended to have on hand black jazz shoes as well, or as needed for costumes).

**Tap classes:** any color/style leotard or fitted tank top, dance pants or shorts, black tap shoes.

**Hip Hop:** any color/style leotard or fitted tank top or t-shirt, dance pants, etc that cover the knees (NO JEANS), black dance sneakers.

### **Tuition:**

**Monthly tuition is due the 1st class of each month and can be placed in the tuition box located inside our lobby.** If you choose to mail your payment please do so at least 10 days in advance to: Canyon Dance Academy, 2922 E. Cleveland Blvd, Suite 600, Caldwell, 83605.

**Returned check fee is \$25 due upon receipt. Tuition not received by the 10th will receive a \$7 late fee.** Individual classes are \$10 each. ***There are no refunds on tuition and dancers will not be allowed to perform in recitals on past due accounts. Months with breaks have been accounted for and therefore do not have a prorated tuition amount.***

### **Attendance: Classes run September 6 through May 24\*\***

It is imperative that students come to class on time for warm-up to prevent injuries. There are no tuition refunds for missed classes. Make-up classes can be arranged with your teacher. Please note that missing class both affects the students and the teacher. If your child falls behind, he or she may need to schedule private lessons to catch up. Private lessons costs are determined by the instructor. If your enrolled class meets twice a week, you must commit to both days. Please give 30 days' notice if canceling enrollment. **Please pick up your child promptly.**

### **Holidays/Studio Closures:**

Unless specifically noted below, classes will always be in session. In the case of weather-related closures, an email will be sent.

There will be **no classes** on the following days:

**Halloween- Tuesday, October 31st**

**Thanksgiving- November 20- November 25**

**Winter Break- December 22- January 4. Regular classes resume Monday, January 8**

**Spring Break- March 18 through March 22. Regular classes resume Monday, March 25.**

COVID/Emergency Closures notifications will be emailed as quickly as possible.

### **Performances: Accounts must be in good standing in order to perform**

**Winter Show** is typically held in December, pending COVID restrictions. There is a \$10 costume fee per class enrolled. Once the costume is returned in good condition your account will receive \$5 credit per class enrolled.

We do our best to give ample notice of that schedule well in advance. In the month of May, we will have pictures taken in your child's costume(s) at the studio. Those will be available for pick up at a later date.

*Reserved Seating Tickets for performances are available to purchase prior to the performances and will be announced in future updates. The funds raised from ticket sales go toward the rental of the facility and other costs associated with the performance.*
